



As per the provisions and norms prescribed in the AICTE Approval Process Handbook (APH) for the Academic Years 2024-25 to 2026-27, the institution proposes to apply for enhancement of intake capacity from 60 to 120 seats in both the existing BBA and MBA programmes from the forthcoming academic session, subject to AICTE approval. For submission of the said proposal on the AICTE Portal, a No Objection Certificate (NOC) from the affiliating university is mandatorily required.
